- The right to data portability You have the right to request that Our Company transfers the data that we have collected to another organization, or directly to you, under certain conditions. We may charge you a small fee for this service.
- The right not to be subject to an automated decision-making- We do not use
 personal data to take decisions producing legal effects concerning you, or
 otherwise significantly affecting you, based solely on automated processing of
 personal data, including profiling.
